*The shares of common stock (the "Shares"), of M I Acquisitions, Inc., a Delaware corporation (the "Issuer"), reported herein are held by Boothbay Absolute Return Strategies LP, a Delaware limited partnership (the "Fund"), which is managed by Boothbay Fund Management, LLC, a Delaware limited liability company (the "Adviser"). The Adviser, in its capacity as the investment manager of the Fund, has the power to vote and the power to direct the disposition of all Shares held by the Fund. Accordingly, for the purposes of Reg. Section 240.13d-3, the Adviser may be deemed to beneficially own an aggregate of 600,833 Shares, or 8.51% of the Shares issued and outstanding as of November 13, 2017. Ari Glass is the Managing Member of the Adviser. The beneficial ownership percentage reported herein is based on 7,058,743 voting Shares issued and outstanding as of November 13, 2017, as disclosed in the Company's Quarterly Report for the quarter ended September 30, 2017, as filed with the Securities and Exchange Commission on November 14, 2017. This report shall not be deemed an admission that the Adviser, the Fund or any other person is the beneficial owner of the securities reported herein for purposes of Section 13 of the Securities Exchange Act of 1934, as amended, or for any other purpose. Each of the reporting persons herein disclaims beneficial ownership of the Shares reported herein except to the extent of the reporting person's pecuniary interest therein.
